

# PLANNING SHEET

## Top bun – Introduction:

- Sizzling start.
- Point of View (what are you persuading your audience)  
eg. You must release me from confinement!
- State 3 reasons why briefly
- Link to first topic/argument

## Body Paragraph 1:

- Topic sentence (1st argument supporting your point of view)
- Evidence (examples to support your point of view) 1 – 2 sentences
- Explain (how this evidence supports your point of view) 1 sentence
- Linking sentence (conclude paragraph by linking to the next topic/argument)

## Body Paragraph 2:

- Topic sentence (2nd argument supporting your point of view)
- Evidence (examples to support your point of view) 1 – 2 sentences
- Explain (how this evidence supports your point of view) 1 sentence
- Linking sentence (conclude paragraph by linking to the next topic/argument)

## Body Paragraph 3:

- Topic sentence (3rd argument supporting your point of view)
- Evidence (examples to support your point of view) 1 – 2 sentences
- Explain (how this evidence supports your point of view) 1 sentence
- Linking sentence (conclude paragraph by linking to the next topic/argument)

## Bottom bun – Conclusion:

- Restate your point of view
- Reminder of the 3 main arguments (take straight from your body paragraphs)
- Memorable final sentence to persuade audience
